TERMS AND CONDITIONS for the Additions Scheme – 2009

1. This Additions Points Incentive is only open to bona fide registered Additions members purchasing Toshiba air conditioning products via Toshiba Carrier UK Ltd (TCUK) directly, or via a Toshiba Authorised Distributor (TAD). The Additions Points Incentive excludes National Account projects or orders placed with negotiated price support.
2. Points will be awarded from the date of paid invoice. The level of points depends on the level of your membership status as defined:
 - Toshiba Accredited Installers receive 1 point for every £30 of invoiced purchases
 - Toshiba Qualified Installers receive 1 point for every £40 of invoiced purchases
 - Toshiba Registered Installers receive 1 point for every £50 of invoiced purchases

Points may only be redeemed for complete Toshiba air conditioning units. New for 2009, the Additions member is also able to redeem the points for Toshiba's selected LCD televisions, laptops, DVDs, DVD recorders, photo frames or Toshiba branded clothing. The items and level of points required can be obtained from your TCUK or TAD representative.

These items may be substituted for a similar item dependent on availability. No specific alternative items can be accommodated and the warranty is with the manufacturer of the item and the Additions Member. TCUK has no involvement in warranty other than for Air Conditioning products.

You will be sent a monthly statement via your purchasing route i.e. either TCUK or TAD.

3. All claims will be vetted by TCUK. In the event of any dispute the decision of TCUK will be final and binding. Each point must be redeemed within 12 months of the invoice date. TCUK reserves the right to amend or terminate the incentive without notice. Should the incentive be terminated, you will be given 3 months' notice in writing sent to the address of registration.
